**For children going through treatment, sometimes the best medicine of all is having family nearby for hugs, kisses and aroha.**

Ronald McDonald House Charities® (RMHC) helps give families the care they need when their child is in a New Zealand hospital away from home.

Each year we offer 3,700 families across New Zealand accommodation and support free of charge. This helps to relieve stresses like paying for a place to sleep near the hospital, organising family meals and needing a friendly ear to listen on tough days.

**Simply, we give families with a hospitalised child what they need most — each other.**

As a charity, RMHC relies on the support and donations from the community to provide our vital service.

## YOUR SUPPORT

Payroll Giving is one of the many ways you can support families that stay at a Ronald McDonald House.

There is no minimum donation amount. With the support of Payroll Givers across the country every donation - large or small - will make a big difference.

**Payroll Giving is the easiest and most tax-efficient way to donate.**

Donations made via Payroll Giving receive an immediate PAYE tax credit of 33% of the donation amount. If you donate \$5 per pay, Ronald McDonald House Charities receives \$5 but it will only cost you \$3.35 per pay.

**\$1** to RMHC = \$0.67 cost to you\*

**\$2** to RMHC = \$1.34 cost to you\*

**\$5** to RMHC = \$3.35 cost to you\*

\*after immediate PAYE tax credit

## FAQs

### If I want to participate in Payroll Giving what do I do?

Talk to your Payroll Manager or contact RMHC.

### What is the minimum donation I can make?

There is no minimum amount set. All donations add up to make a big difference.

### Do I have to participate in Payroll Giving?

No, this is entirely optional.

### Can I stop participating in payroll giving?

Yes, you can stop at any time. Simply tell your Payroll Manager you would like to stop donating. And when you are ready to start contributing again, let your Payroll Manager know. You can also reduce the amount you are donating at any time.
